REGISTRATION FEES:

The non – refundable General Purpose Levy is payable within 7 days after the student has been accepted to the College before starting their tuition.

MONTHLY TUITION FEES:

The fees are payable in advance, before the 3rd day of each month unless alternative arrangements have been agreed upon in writing. In the instance of a default payment:

- A SMS, email, or phone call will be made on the 7th day of the month
- R100 will be added to the next account for administration fees
- From the 10th day of the month tuition is suspended and the learner is not allowed on the school premises until payment has been made

OTHER:

- Payment via EFT directly into the school's bank account
- No Cash Payments will be accepted at the school office for safety reasons
- One Calendar month notification must be submitted in writing in case of de-registration of learners. If in default, one month's school fee is still liable
